1. I.W.C.O.A. Members will adhere to all laws and regulations pertaining to wildlife damage management.
2. I.W.C.O.A. Members will ascribe to a professional code of conduct that embodies the traits of honesty, sincerity and dedication.
3. I.W.C.O.A. Members will show exceptionally high levels of concern and respect for people, property and wildlife.
4. I.W.C.O.A. Members will promote the understanding and appreciation of the numerous values of wildlife and scientific numerous values of wildlife and scientific wildlife management, as well as an appreciation for the economic and health concerns of humans adversely affected by wildlife.
5. I.W.C.O.A. Members will be sensitive to the various viewpoints on wildlife damage management.
6. I.W.C.O.A. Members will provide expertise on managing wildlife damage to their clientele upon request, within the limits of their experience, ability and legal authority.
